- e) Primary Site Update Shelly Craig commented on the following:
 - 1) there is increasing publicity and attendance at Coffee with the Principal
 - 2) four (4) students have transitioned from CDS to the Elementary School
- f) Elementary Site Update Mr. Dell commented on the following:
 - 1) Boys Basketball the teams have had several home games recently and a tournament this past weekend. The event was very well attended by students, staff, and community members. The 7^{th} grade team took the banner and the 8^{th} grade team won their first game.
 - 2) the 8th grade graduation committee continues to meet and plan. The annual Dinner/Dance will be held on February 29th. While still in the planning stages, there is the possibility of a concert to raise money for the 8th grade class. Win-River has agreed to donate the venue. Chad Bushnell, a local musician, has been contacted to headline the event. If all of the details work out the concert could take place in March. This would be a 21 and older event.
- 9.2 Superintendent Update Helen Herd reported on the following:
 - 1) her workdays will be reduced to four (4) per week with the approval of the amended Superintendent contract.
 - 2) the Food Services Director resigned at the end of Winter Break. The food service staff has stepped up to help out wherever possible.
 - 3) Food Services is in review this year.
 - 4) the district is in Differentiated Assistance due to the amount of suspensions in the 18/19 school year.
- 9.3 Business Manager Update Beth Roberts reported the following:
 - 1) the Business Services contract will be brought to the board next month for renewal. The contract will show a \$7,000.00 reduction in the cost of services.
 - 2) the Budget Committee met this afternoon to go over expenses and look for any possible reductions.
 - 3) the Governor has released his January projection for 2020/21. Another update will be released in May.
