 Cheryl Frazer reported that 4H has started and anyone interested in having their child participate should contact her; the 4H students will be selling Mandarins for their first fundraiser of the season.
 - e) Primary Site Update Karen Maki reported the following: Parent/Teacher conferences were held last week; the Library opened this week; each cohort received a bag of equipment for playground usage; staff and students are settling into a daily routine; the Book Giveaway saw a very large turnout with 1500 books going home with the students and their families and six boxes of books were donated to Zogg Fire victims.
 - f) Elementary Site Update Shelly Craig reported the following: staff and students participated in Constitution Day by wearing Red, White, and Blue clothing, singing songs and having a costume contest; students participated in a bus evacuation drill; picture day was held at both school sites; student led Zoom conferences were held for Parent/Teacher conference week; students will participate in a Nicotine Prevention presentation in the upcoming weeks; teacher mentors are working with new teachers on campus and are doing a great job; SPED teachers are working very hard to catch up with required meetings at both sites.
- 11.2 Superintendent Update Ms. Herd reported the following: student testing is in the works to determine where students are academically after distance learning; a request has been made by the athletic director to resume afterschool sports. However, that request is being denied for now due to the still uncertain logistics of how that would work with all of the safety requirements in place.
- 11.3 Business Manager Update Beth Roberts reported the following: the phone system upgrade is moving forward; the spending deadline has been extended to June for the federal Covid money that was given to the district; the electric bus grant has been submitted; the district will have exhausted its cash flow by May and will be applying for a TRAN loan from the state. Re-payments for the loan will start in

September with the balance being paid in full by the end of December.
